# ACHIEVEMENTS



With the support of our community, in 2012 we made great strides in meeting the health and wellness needs of our community:

### We provided a respectful healthcare home

- Provided 196,395 visits to 49,565 people
- Provided 7,593 emergency dental visits
- Helped 381 babies join our community
- > Cared for 8,220 homeless or recently homeless individuals

### We improved the health of the community

- > All of our primary care clinics received Patient Centered Medical Home status at Level 3, the highest level possible
- Neighborcare Health surpassed health center averages, both state and national, on critical health indicators, including:
  - Women having a first prenatal visit in the first trimester
  - Two-year olds immunized
  - Diabetic patients whose condition is controlled

### To strengthen our capacity to serve our neighbors, we

- > Nearly doubled the capacity of our Ryan White dental program to provide 2,735 general dentistry visits per grant year
- > Were awarded a federal New Access Point grant to establish the Lake City Medical Clinic
- Expanded our Homeless Programs by opening the Ballard Homeless Clinic
- Held our inaugural Spring Dinner
- > Opened two of Seattle's first elementary school-based health centers; four more elementary school clinics will open in the fall 2013
- Were awarded two federal capital grants to remodel the 45th Street Medical & Dental Clinic, and to build a new facility for the Greenwood Medical Clinic

# DENTAL CARE:

### Delivering Dental Care to Underserved Communities

Neighborcare Health is the largest provider of dental care services to low-income, uninsured and homeless people in Seattle. Our safety net dental program provides quality care to those who need it most and places a priority on serving children, pregnant women, patients with diabetes and patients who are HIV positive.

We strive to get children into their first dental appointment by age 1, as evidence shows that establishing good dental hygiene habits early will reap benefits for years to come. Further demonstrating this idea, we emphasize the importance of proper dental health in pregnant women as there is a correlation between a mother's oral health and her child's oral health.

Dental education extends outside of our clinic walls and directly into the community. Because we understand that those who need care the most might also face the largest barriers to access, in 2012 we coordinated efforts to bring dental education into the neighborhoods where our clinics are located. With the help of our AmeriCorps members, we provided dental presentations in schools all throughout Seattle.




Our Ryan White Dental Program, which provides dental services to those who are HIV positive, also experienced significant growth in the past year. In 2012, our capacity to serve Ryan White eligible patients increased from 1,915 visits per year to 3,438 visits per year, an 80% increase. Neighborcare Health is the only Ryan White funded provider offering services in King County.

Access to quality dental care is the most egregious health disparity that our marginalized neighbors in Seattle face. We have been busy laying the foundation to expand our services into communities that feel that disparity the most; we look forward to increasing our capacity to provide dental care in the years to come.

# FEATURE STORY:

### Meeting Community Needs in Seattle's North End

In recent years Neighborcare Health has made great strides in addressing facility needs, and therefore access, in our south most clinic sites in Seattle. In 2012 we shifted our focus to Seattle's north end, the area of the city with the largest number of low-income people not yet served by a health center.

Thanks to the award of three competitive federal grants, in 2012 we set the foundation for addressing clinic needs in the north end:

\* A Federal Building Capacity grant will support a replacement of our undersized Greenwood Medical Clinic. Our project is not simply a new facility, but an innovative partnership with Public Health - Seattle & King County that will integrate Neighborcare Health, Public Health and a host of other health, wellness and human services at a site in the Northgate area. In addition to its array of integrated services, the new facility will triple the access of the current Greenwood site. Development began in 2012, and we expect to break ground in 2014.

\* An Immediate Facilities Improvement grant will fund the first phase of a major remodel of the 45th Street Medical, Dental and Homeless Youth Clinic. The remodel will result in many improvements to this historic landmark site, most notably increasing access for disabled patients and enhancing efficiencies. This project will take place in 2013, which is the 20th anniversary of Homeless Youth Clinic; a clinic offered twice weekly which cares for 500 homeless youth annually.

\* A New Access Point Grant provides ongoing funding for Lake City Medical Clinic, which opened its doors in the fall of 2012. While it currently serves patients, the clinic will undergo a remodel to allow it to serve over 3,000 patients on an ongoing, annual basis.


